

Annual General Meeting of INFICON Holding AG of April 29, 2014

Out of a total of 2'311'398 registered shares at a nominal value of CHF 5.00, 1'672'371 registered shares were represented. 82 shareholders and shareholders' representatives were present. The independent proxy holder represented 1'625'109 shares. In all, CHF 8'361'855.00 of the share capital or 72.35 % of the entire capital of CHF 11'556'990.00 were present or represented.
